“Clarence Darrow, Humanist Hero”

Join us on Sunday, May 26, at 2 p.m., when we'll hear about the efforts of Clarence Darrow, Esq., whose historic battle to defend the teaching of Darwin's ideas against Williams Jennings Bryan, Esq., in Tennessee's Scopes Trial has become an almost legendary part of America's past. This latest installment in the popular series of biographical sketches of “Humanist Heroes,” by our vice-president, Rev. Douglas Peary, will place the trial in the rich context of Darrow's lifelong battle against ignorance and intolerance.

We hope and expect that Doug will be able to present the talk himself, but as he is presently recuperating from serious surgery to repair an arterial aneurysm in his brain he has given a copy of it to Rev. Robert Rafford to deliver, just in case. Either way we can expect an enlightening and stimulating talk, followed by a lively discussion.

We'll start off the afternoon at 2:00 with refreshments and informal conversation. At 2:20 Joe Stachelek, will speak on “Why I Am a Humanist.”

Picnic Directions - June 1

Our annual picnic will be held June 1, rain or shine, at the lovely home of Dr. Rob and Ms. Joan Rafford, 57 Clearview Knoll Rd., Middlebury. Festivities run from 12 noon, to between 3 and 4 p.m.

Bring something to eat and drink for yourself, a little food to share (hot or cold, salad, dessert, fruit, vegetables, or what have you), and please bring a chair. The Raffords will provide hot dogs on the grill.

From the New Haven area:

Take Rte. 8 north to I-84 and go west to Exit 17. From the exit go straight ahead (west) on Rte. 64 to the stoplight...

From the Stamford area:

Take Rte. 7 north to I-84 and go east to Exit 17. At the exit turn left onto Rte. 63, go straight to the stoplight (Rte. 64), and turn left again onto Rte. 64...

From the junction of Rte. 64 with Rte. 63:

Head west on Rte. 64 less than one mile, passing through one more stoplight. If you pass a gas station you have gone too far. On the right, look for Tzepos Law Firm sign. At that sign, turn right onto Clearview Knoll Road and drive to the top of the hill. #57 is on the left. Park in the driveway (2 cars wide) or on the street.
