The High Cost of Prescription Drugs

A year after this talk was originally planned, pharmaceuticals are still the fastest growing healthcare cost in America, and there is still no letup in sight. For many, prescription drugs are a major cost of living, alongside food and housing; some simply can't pay for the medicines needed.

Today's advances in biology make possible an unprecedented explosion of new drugs. While these new drugs may lower overall healthcare expenditures while improving health, these costs are often passed along directly to the consumer because a patient's medicines are less likely to be paid by insurance than his/her healthcare services. Furthermore, it is especially aggravating to many that companies charge people in other countries far less than Americans for the same drugs.

On October 21, Manny Ratafia will discuss how the current situation came about and what can and should be done to change it. He will review the roles of doctors, hospitals, pharmacies, pharmaceutical and biotech companies, employers, governments, the media, and our behavior as consumers.

Manny has consulted and published reports on biotechnology, pharmaceuticals and other technology-based industries. His research and opinions have been published and quoted in more than 100 general, trade and scientific publications around the world including *Business Week*, *Forbes*, *Fortune*, *The Wall Street Journal* and *The New York Times*. He has been interviewed on national and international television and on U.S. radio programs. His reports have been purchased by the major pharmaceutical and biotechnology companies as well as governments, universities and consulting firms throughout the

God In the Pledge: What Should We Do?

A Community Forum on “God In the Pledge: What Should We Do?”, featuring Dr. Michael Newdow and a distinguished panel representing a variety of views, is being organized by the Congregation for Humanistic Judaism to be held in Westport at the Unitarian Church at 3 P.M. on Sunday November 10. Dr. Michael Newdow is the man who single-handedly presented the “Under God” issue successfully to the Federal Ninth District Appellate Court. The Appellate Court ruled that the 1954 law, which changed the Pledge of Allegiance by adding the words “under God”, was unconstitutional. The court did not rule that the original Pledge, or that teaching it in classrooms, was unconstitutional. It did rule that the amendment “put students in the untenable position of choosing between participating in an exercise with religious content or protesting.”

The main event will take place on Saturday, November 2, 2002. The Godless Americans March

On Washington will be held on the National Mall, with a march and rally at the west side of the US Capitol Building.

The march itself begins promptly at 11:00 a.m. We will assemble on the mall on the east side of 14th street near the Washington Monument. Groups and individuals will form up behind a large Godless Americans banner for the parade in the direction of the capitol, and head down the wide pedestrian path.

Godless Americans March On Washington Marshals will be available to direct the flow of the march, answer questions and deal with any special needs or other situations.

The march will take 20-30 minutes. Once assembled at the rally location, we [American Atheists] will have a program including speeches from representatives of various Atheist, Freethought, Secular Humanist and other nonbeliever groups, along with entertainment.
